

CORELIGHT PRODUCT-SPECIFIC TERMS

The following Product-Specific Terms apply to the Products or features specified below and, where Customer procures such Products, supplement the Corelight Customer Agreement or other written agreement entered into between Customer and Corelight governing Customer's use of the Products and/or Services ("**Agreement**"). Capitalized terms used and not defined in these Product-Specific Terms have the meanings given to them in the Agreement, or if not defined in the Agreement, in the Corelight Customer Agreement located at www.corelight.com/legal/agreements (or such successor URL as may be designated by Corelight).

1. CORELIGHT SENSORS.

1.1. Applicable Usage Metrics.

- (a) **Corelight Sensors.** This Section 1.1(a) applies to all Corelight sensor types except the Corelight sensor type set forth in Section 1.1(b) below ("**Sensor(s)**").
 - i. **Measurement.** Sensors are measured on a Gbps basis using the metering metric, as indicated in the applicable Order.
 - ii. **Capacity Entitlement.** Sensors are offered on a 5-Minute Average metering metric. Corelight calculates a Sensor's throughput after input filtering and by averaging that network traffic volume over a five-minute interval (based on standard clock five-minute increments, not a rolling basis) ("**5-Minute Average**"). Customer's inbound NIC traffic throughput may reflect a higher capacity than a Sensor's 5-Minute Average reports because the 5-Minute Average excludes network traffic removed by input filtering. Corelight calculates Customer's total throughput capacity by adding together the 5-Minute Average across the total number of Sensors in the same five-minute interval. The 5-Minute Average is rounded down to the nearest integer. For example, if Customer's 5-Minute Average is 9.7 Gbps, that is counted as 9 Gbps. Customer may use Sensor(s) up to the capacity purchased under the applicable Order ("**Capacity Entitlement**"). Customer will not use Sensors to monitor more network traffic than the Capacity Entitlement, and it is solely Customer's obligation to not exceed the Capacity Entitlement. Customer acknowledges and agrees that network traffic exceeding the Capacity Entitlement may not be monitored by Sensors.
 - iii. **True Forward Capacity Reviews.** During the Subscription Term, Corelight will conduct quarterly reviews of usage data logs for Customer's Sensor deployment to determine utilized Gbps capacity ("**Capacity Review**"). Corelight will not retroactively charge for excess capacity consumed before each Capacity Review. If the results of a Capacity Review indicate that Customer's Monthly Peak Usage exceeds Customer's Capacity Entitlement for any two months in the three-month Capacity Review period, then Corelight reserves the right to invoice Customer for Incremental Capacity and Customer will pay all such charges. Incremental Capacity charges will be prorated from the date a Capacity Review concludes to the end of the Subscription Term. "**Monthly Peak Usage**" refers to the highest remaining 5-Minute Average interval reported during a calendar month after excluding the top five percent of 5-Minute Average intervals during such month. "**Incremental Capacity**" is calculated by (i) averaging the Monthly Peak Usage across each of the months that exceeded Customer's Capacity Entitlement less (ii) Customer's Capacity Entitlement.
- (b) **Corelight Flow Log Sensor.**
 - i. **Measurement.** Corelight Flow Log Sensor ("**Flow Monitoring**") is measured on a per GB basis using the metering metric, as indicated in the applicable Order. In this context, a GB is defined as 1 billion bytes.
 - ii. **Capacity Entitlement.** Flow Monitoring is offered on GB Ingested metering metric. "**GB Ingested**" means the initial volume of raw Flow Logs read by Corelight, before deduplication, normalization or other data operations. "**Flow Logs**" mean Amazon Web Services (AWS) VPC Flow Logs. Monthly GB Ingested is rounded down to the nearest integer. For example, if Customer uses 490.8 GBs during a month, that is counted as 490 GBs. Customer may use Flow Monitoring up to the capacity purchased under the applicable Order ("**Capacity Entitlement**"). Customer will not use Flow Monitoring to read more GBs of raw AWS VPC flow logs than the Capacity Entitlement, and it is solely Customer's obligation to not exceed the Capacity Entitlement. Customer acknowledges and agrees that raw AWS VPC flow logs exceeding the Capacity Entitlement may not be read by Flow Monitoring.
 - iii. **True Forward Capacity Reviews.** During the Subscription Term, Corelight will conduct quarterly reviews of usage data logs for Customer's Sensor deployment to determine utilized GB Ingested capacity

(“**Capacity Review**”). Corelight will not retroactively charge for excess capacity consumed before each Capacity Review. If the results of a Capacity Review indicate that Customer’s Monthly Usage Level exceeds Customer’s Capacity Entitlement for any two months in the three-month Capacity Review period, then Corelight reserves the right to invoice Customer for Incremental Capacity and Customer will pay all such charges. Incremental Capacity charges will be prorated from the date a Capacity Review concludes to the end of the Subscription Term. “**Monthly Usage Level**” refers to GB Ingested during a calendar month. “**Incremental Capacity**” is calculated by (i) averaging the Monthly Usage Level across each of the months that exceeded Customer’s Capacity Entitlement less (ii) Customer’s Capacity Entitlement.

1.2. **Sensor Sites.** Customer may install and use each Sensor at the applicable site(s) designated by Customer when making an Order (each, a “**Site**”). Customer may move any Sensor(s) (and the Software thereon, where applicable) to a new Site upon written notice to Corelight.

1.3. **Physical Sensors.** Hardware-based Sensors require the purchase of an associated Software subscription to function; Hardware may not be used and will not function without a valid corresponding Software subscription deployed on such Hardware. The Software subscription that is provided in conjunction with a Hardware appliance is only valid for use with that Hardware appliance, unless such appliance is replaced pursuant to Corelight’s Hardware RMA policy.

2. **CORELIGHT INVESTIGATOR.**

2.1. **Applicable Usage Metrics.**

- (a) **Measurement.** Corelight Investigator (“**Investigator**”) is measured on a Gbps basis and/or per GB basis using the metering metric(s) of the Corelight Sensor type(s) that Customer deploys.
- (b) **Capacity Entitlement.** Customer may use Investigator up to the relevant capacity (as described in Section 1) purchased under the applicable Order (“**Capacity Entitlement**”). Customer will not use Investigator in excess of the Capacity Entitlement, and it is solely Customer’s obligation to not exceed the Capacity Entitlement. Customer acknowledges and agrees that use exceeding the Capacity Entitlement may negatively impact the operation of Investigator.
- (c) **True Forward Capacity Reviews.** During the Subscription Term, Corelight will conduct quarterly reviews of usage data logs for Customer’s Investigator deployment to determine utilized Gbps and/or GB Ingested capacity (as applicable) (“**Capacity Review**”). Corelight will not retroactively charge for excess capacity consumed before each Capacity Review. If the results of a Capacity Review indicate that Customer’s Monthly Peak Usage and/or Monthly Usage Level (as applicable) exceeds Customer’s applicable Capacity Entitlement for any two months in the three-month Capacity Review period, then Corelight reserves the right to invoice Customer for the applicable Incremental Capacity and Customer will pay all such charges. Incremental Capacity charges will be prorated from the date a Capacity Review concludes to the end of the Subscription Term.

2.2. **Maximum Log Retention Periods.** Investigator will retain logs for the defined period of time selected by Customer and stated in the applicable Order (“**Retention Period**”). By default, Investigator retains logs for a thirty-day Retention Period unless additional days are purchased. Logs will be erased at the end of the applicable Retention Period, and new logs will be stored in their place, so that at any time during the Subscription Term, logs for the most recent Retention Period will be accessible to Customer. By way of example, and without limiting the generality of the foregoing, if Customer purchases a forty-day Retention Period, then at any point during the Subscription Term, Customer will have access to logs from the immediately preceding forty-day period, but not to any logs before then.

- 3. **SIZING.** To the extent Corelight participates in any sizing analysis, it is only for purposes of providing an estimate using information provided by Customer or a third party acting on Customer’s behalf. Corelight does not validate the accuracy of any sizing-related information it receives. Customer is solely responsible for all sizing decisions and for any inaccuracies in any sizing analysis.
- 4. **AI FEATURES.** Customer determines in its sole discretion whether or not to enable use the optional artificial intelligence (AI) features made available by Corelight in connection with Corelight Products (“**AI Features**”). Once enabled, Customer can also disable use of such AI Features at any time. When a Corelight Product’s optional AI Features are enabled, Customer Data is processed for one-time inference only and is not stored or used for training purposes. Any AI-generated outputs in Corelight Products are clearly marked to indicate they are produced by a model to distinguish them from human-authored content.

5. **DEFENSIVE PURPOSES ONLY.** Corelight Products may not be used for any purpose other than cyber-defensive purposes (e.g., Customer may not use the Corelight Products to monitor data or traffic on any network, computer or communication system without authorization).
